## 1. COLOURS AND LOGO

- 1.1 The club colours shall be gold and black
- 1.2 The club logo shall be a Tiger.

## 2. CLUB MEMBERSHIP

### 2.1 Ordinary Members, comprising:

- (a) Playing Members
  - (i) Such Members shall pay any subscription as decided by the Committee before the start of the season. Such subscription must be paid in full by the 30<sup>th</sup> October in the year of application.
  - (ii) Playing Members are required to be registered in MyCricket correctly as required. Members must provide updated details to the secretary/registrar for this purpose.
- (b) Junior/Student Playing Members
  - (i) Any player who is younger than 18 and/or a student before the commencement of the season will be entitled to a match fee discount, at the Committee's discretion to be set before the commencement of the season.
  - (ii) Proof of age and/or student capacity is required at time of registration.
- (c) Social Members
  - (i) Social membership fees will be decided by the Committee before the commencement of the season.
  - (ii) Should a Social Member be selected to play for the Club in an Association fixture match, they shall become a Playing Member and assume all requirements of a Playing Member as set out in the appropriate rules of this Constitution.
- (d) Life Members
  - (i) Life Members are extended Ordinary Members rights in perpetuity, subject to not being expelled under section 11.3 of the Constitution.
  - (ii) Life Members are not subject to Club Membership fees as per Rule 3.4 (b) and entitled to match fee discount, at the Committee's discretion to be set before the commencement of the season.

### 2.2 Un-financial Members

- (a) No Playing Member who is at any point 2 weeks in arrears of subscription/match fees shall be eligible for selection in any future team of the Club, except if:
  - (i) The Member involved has discussed their situation with the club Treasurer and an arrangement has been agreed to whereby all outstanding amounts will be repaid within a defined timeframe.
  - (ii) Should the conditions of any arrangement reached under 2.2 (i) not be adhered to the player will be ineligible until the outstanding amount has been paid in full.

## 3. LIFE MEMBERSHIP

- 3.1 The Club may award a Life Membership to any person for long meritorious and distinguished service to the Association.
- 3.2 The following conditions are to be observed in the election of Life Members;
  - (a) The Committee shall consider nominations presented for the nomination of any person for Life Membership requires unanimous vote from all Committee members.
- 3.3 Meritorious and distinguished service can include 150 games for the club, or 15

years serving on the Club Committee or a combination of both (i.e. 15 years on Committee = 150 games)

- 3.4 Not more than four (4) people may be elected to Life Membership of the Association in one (1) year.
- 3.5 The Life Members are entitled to honorary membership of the Association.
- 3.6 Should the Association at any time cease to exist it would be the duty of the Life Members to act as Executors of the Association at that time.

### 4. MATCHES

#### 4.1 Forfeits

Where the Club has two (2) or more teams playing, the teams playing in the higher grades shall not be allowed to forfeit any match without the approval of the Chairperson/President.

#### 4.2 Match Fees

Ball fees shall be fixed before the commencement of the first match of each season.

#### 4.3 Dress

All senior players shall take the field in the approved dress i.e. long white or cream trousers, white or cream shirt, predominantly white shoes or boots and white socks. Association of Cannington Tigers Cricket Club Inc. caps or white-washer hats are the only acceptable head gear.

### 5. COMMITTEE MEETINGS

- 5.1 The Committee must meet monthly between September to March and at least twice between April to August.
- 5.2 The Committee is to determine the place and time of all Committee Meetings.
- 5.3 Special meetings of the Committee may be convened under section 18.2 by
  - (a) the President; or
  - (b) any two (2) Committee Members.

### 6. TROPHIES

- 6.1 The Committee shall appoint one or more to finalise the results and organise trophies as required.
- 6.2 Trophies for each playing grade will consist of;
  - (a) Bowling (20 wickets to qualify or aggregate where no person qualifies)
  - (b) Batting (200 runs to qualify or aggregate where no person qualifies).
  - (c) Fielding (Votes per game are submitted and counted at end of playing season.
  - (d) Where numbers of votes are equal the Committee shall decide awards).
- 6.3 Association trophies shall consist of;
  - Cricketer of the Year (Paul Keep Cricketer of the Year Award)**
  1. This award goes to the cricketer who accumulates the most points earned over the season from batting, bowling, and fielding. Extra points are given to players who make 50 or 100, take 5 wickets or more in a match and run out a player with a direct hit.
  2. 20 points per wicket, 10 points per catch/stumping and 1-point per run.
  3. First innings only are considered in deciding this trophy. Points will be doubled (for the club award only) if acquired in a two (2) day game.
  4. Players who refuse to play in their selected grades be ruled ineligible for that season's Cricketer of the Year award, unless the committee consider exceptional circumstance exist.

**Club Person of the Year "The Frank Macgrotty Award";**

Decided by Committee members, based on persons work value to the club either a supporter or player.

**Social Supporter of the Year;**

Decided by the Committee members, based on persons social and supportive achievements within the Association.

**Duck Award "The Clayton Brown Award"**

Player/s earning the most ducks in the season

**Spirit of Cricket "The Syd Godfrey Award"**

To win this award player has to train till the end without giving up and help without getting asked.

The Committee will award trophies to any person achieving: 100 runs in an innings (**Mclean / McGrotty Award**); taking three (3) wickets on successive balls, taking five (5) or more wickets in a single innings, and other feats of excellence as deemed necessary.

## **7. SELECTION COMMITTEE**

- 7.1 The selection committee shall be appointed by the Committee.
- 7.2 The formulation of the selection committee shall be decided by the Committee.
- 7.3 In the case of Junior sides, the coaches shall comprise the selection committee.
- 7.4 Selections shall be announced no later than Thursday, prior to each match.
- 7.5 The Selection Committee may appoint an emergency player for each grade.

## **8. CAPTAINS**

- 8.1 The Committee shall appoint the first-grade captain.
- 8.2 The Selection Committee may appoint all other senior grade captains and Vice-captains. The selection committee may review the position of the captain and vice-captains at any stage during the season.

## **9. AFFILIATION**

- 9.1 The club is affiliated with the South Metropolitan Cricket Association (SMCA) and as such members of the Cannington Tigers Cricket Club Inc. shall also be bound by the bylaws of the SMCA and be punishable by the SMCA according to those bylaws.

## **10 COACHING**

- 10.1 On the approval of the Committee the Association may appoint a paid coach, and all coaches will be offered free membership.
